Smart Saver 6 Starter

Prompt Payment Discount: 6% off the usage charges when the account is paid in full by the due date.

Rates: Usage charges and fixed supply charges are equal to the Australian Power & Gas Prices applicable to your home.

Contract Term: 12 months. 20 business days' notice required for cancellation by customer.

Cancellation Fees: \$88 inc GST (\$80 ex GST) per fuel if cancelled at any time during the contract term.

Smart Saver 10

Prompt Payment Discount: 10% off the usage charges when the account is paid in full by the due date.

Rates: Usage charges and fixed supply charges are equal to the Australian Power & Gas Prices applicable to your home.

Contract Term: 3 years. 20 business days' notice required for cancellation by customer.

Cancellation Fees: \$88 inc GST (\$80 ex GST) per fuel if contract cancelled in first year, \$22 inc GST (\$20 ex GST) per fuel if cancelled in second or third year.

Simplicity Plus

Prompt Payment Discount: 5% off usage and supply charges when your energy account is paid in full by the due date.

Rates: Usage and fixed supply charges are equal to the Australian Power & Gas Prices applicable to your home.

Contract Term: No fixed term.

Cancellation Fees: None.

Schedule of fees and charges

Separate to your rates (shown on the other side of this Pricing Schedule), other fees and charges may apply to you.

Connection charge: You are liable for any charges we incur from your Energy Distributor for providing connection services to your premises, including any reconnection fees. No fee is charged for reconnections scheduled during business hours. You may be charged \$104.50 (including GST) for reconnection after business hours.

Disconnection charge: If your premises is disconnected or cancelled under your Energy Contract, you are liable for any charges we incur from your Energy Distributor for the discontinuance of connection services. You may be charged a disconnection fee of \$96.80 (including GST).

Cancellation fee: If your Energy Contract has a fixed term and you cancel it before the expiry date, you may be charged a cancellation fee as set out in this Pricing Schedule.

Late payment fee: If you do not pay your Energy Account by the due date and we have not agreed an alternative payment arrangement with you (for example, instalment plan), you may be charged a late payment fee of \$10 (including GST). If your payment is more than 30 days late, you may also be charged interest at a rate equal to the rate prescribed under section 101 of the *Civil Procedure Act 2005* (NSW) for payment of interest on a judgment debt. Interest is calculated daily until the date of payment and capitalised on the first business day of each month.

Special meter reading charges: You must pay a special meter reading charge of \$48.40 (including GST) if you request a meter reading at a time other than as scheduled by your Energy Distributor in the ordinary course of the meter reading cycle, or if your Energy Distributor charges us for a special meter reading as a result of your failure to provide access to your meter.

Debt recovery fee: If you do not pay your Energy Account on time, we may require you to pay our reasonable costs for recovering the outstanding amount from you, including debt collection fees.

Other retail fees and charges: We may incur other costs relating to the sale of energy to you, including but not limited to charges or taxes imposed on us from time to time by the government, Energy Distributors, other energy industry participants, or our service providers. Consistent with Energy Laws, we may require you to pay other retail fees and charges relating to these costs, to the extent that they are fair and reasonable. This includes amounts relating to any costs, charges or taxes incurred directly or indirectly by us in connection with the introduction of, or compliance with, a carbon price or pollution reduction scheme, or other emissions trading or reduction scheme.

Solar Bonus Scheme: You will receive 60 cents (including GST) per kWh for energy fed back into the grid from eligible generators registered with your Energy Distributor on or before 27 October 2010. For eligible generators registered between 27 October 2010 and 29 April 2011, the Solar Bonus Scheme will pay 20 cents (including GST) per kWh.
