Simplicity Plus

Contract term:	No fixed term.
Cancellation fees:	None.
Prompt Payment Discount:	5% off the usage and supply charges when the account is paid in full by the due date.
Rates:	Usage and fixed supply charges are equal to the Australian Power & Gas Prices applicable to your home (shown on the other side of this Price Fact Sheet).

Savings Plus

Contract Term:	3 Years.
Cancellation Fees:	\$60 ex GST if contract is cancelled in first year, \$50 ex GST per fuel is cancelled in second year or \$40 ex GST if contract is cancelled in third year.
Prompt Payment Discount:	3% off the usage and supply charges when the account is paid in full by the due date.
Up front rebate:	\$25 inc GST (\$22.73 ex GST) off your first Energy Account.
Rates:	Usage charges are 3% less than the Regulated Prices. Fixed supply charges are equal to the Australian Power & Gas Prices applicable to your home (shown on the other side of this Price Fact Sheet).

Dishonoured payment	Retailer*	\$50 inc GST (\$45.45 ex GST)
Late payment fee	Retailer	\$10 inc GST (\$9.09 ex GST)
Security deposit	Retailer	The amount of the security deposit will not exceed 1.5 times the estimate of your energy costs over a three month period.
Meter testing fee (business hours only)	Network**	\$15.90 inc GST (\$14.45 ex GST)
Meter check read (off cycle)	Network	\$8.25 inc GST (\$7.50 ex GST)
New connection charge	Network	No fee for a standard connection. Non-standard connection fee depends on supply availability.
Reconnection charge	Network	\$39.85 inc GST (\$36.23 ex GST)
After hours reconnection	Network	\$95.65 inc GST (\$86.95 ex GST)

Debt recovery fee: If you do not pay your Energy Account on time, we may require you to pay our costs for recovering the outstanding amount from you, including debt collection fees.

Disconnection charges: If you provide us with less than 20 business days' notice to discontinue supply of energy to your premises, you will be liable for all charges for energy supplied and damages for connection services. You will be liable for these charges until the supply is discontinued or transferred, or you enter into a new supply contract, whichever happens first. You will also be liable for all charges payable to your network operator arising from the discontinuance of supply to your premises.

Special meter reading charges: You must pay \$8.25 inc GST as indicated above if you request a meter reading at a time other than as scheduled by your network operator in the ordinary course of the meter reading cycle, or if your network operator charges us for a special meter reading as a result of your failure to provide access to your meter.

Paper bill fee: We are currently working on introducing an option for you to receive your Energy Account by email. If you have provided us with a valid email address by the time this is introduced, we will email your Energy Account to you free of charge. If you request a paper bill or you do not provide us with a valid email address, we will send your Energy Account to you at your nominated postal address and you will be charged a fee (TBA) for each paper Energy Account sent to you. No paper bill fees will be introduced until email billing becomes available.

Additional charges: Other costs and charges may be incurred by us relating to the sale of energy to you, including but not limited to charges or taxes imposed on us from time to time by the government, energy distributors, other industry participants, or our service providers. Consistent with the law, we may require you to pay an amount(s) relating to these other costs and charges.

You must also pay us any charges or levies imposed on your Energy Contract by, under or in respect of the *Community Ambulance Cover Act 2003* (Qld).

You may also be required to pay amounts relating to any costs, charges or taxes incurred directly or indirectly by us in connection with the introduction of, or compliance with, a carbon pollution reduction scheme or other emissions trading or reduction scheme.
